

LEGAL BASIS FOR GIVEAWAYS

1. Organizing Company

The raffle is organized by ES PLA S.A., with CIF A-07055320 and registered office at C/ Vicente Cuervo, number 9, 07800 Ibiza, Balearic Islands, hereinafter and indistinctly the ORGANIZER.

2. Specific Rules

The requirements for participation will be those described in the promotional materials for the sweepstakes, which will be detailed below. They will include the necessary information regarding the duration, method of participation, cost of participation, as well as the location of the general rules of participation, available at www.invisahoteles.com.

The ORGANIZER reserves the right to make any modifications or add any appendices to these Rules regarding their mechanics and prizes that it deems appropriate, provided that they are justified, do not harm participants, are made within the promotion period, and are published in the same medium as these Rules.

3. Acceptance of the Rules

Participation in this raffle implies full and unconditional acceptance of these general and specific rules established by the ORGANIZER. Recognition as a valid participant is subject to compliance with the requirements established in section 4 of these general rules.

The ORGANIZER reserves the right to disqualify participants who do not comply with these rules and/or who violate these rules.

4. Participation Requirements

7. Raffle Operation

The winner will be selected using a random draw application.

8. Winner Selection

The ORGANIZER will contact the winner via DM, and the winner must accept the prize within the next 4 hours. If they do not respond, do not accept, or do not meet the requirements, alternates will be contacted, up to a maximum of 10, in consecutive order of drawing.

Withdrawal or failure to comply with the requirements will result in forfeiture of the prize.
